OUR ROOMS:

WAITING ROOM :

equipped with an instrument to eliminate the queue, to check the order of arrival of the Clients and the waiting time; equipped of a TV that remains turned on during the waiting of the Clients; it's also present a souns system in alternative to the TV.

It's possible to download the greatest part of the examinations, except for particular tests that contains papery enclosures or that must be exclusively delivered to the patient (es. HIV test).

PRIVACY

The privacy of the client in phase of acceptance is guaranteed by the distance of courtesy signed by a yellow line.

During the acceptance the patient is informed, also through posted poster, about the treatment of the Reg.UE 679. The administrative personnel is available to provide every information about the privacy.

The delivery of the medical reports is in closed box and after the presentation of the sheet to pick up.

The delivery of the medical reports related to the HIV test is exclusively reserved to the concerned person.

Release form to the treatment of the personal data.

Prevention of the non authorized access to the data: The managerial Computer System of the Laboratory LEPETIT works online local, for the access to which exists a password known only by the authorized personnel.

MEDICAL REPORTS DELIVERY:

The greatest part of the examinations are daily delivered, particularly the examinations of chemistry-clinic; for the greatest part of the remaining examinations the delivery happens in about two days; except for the examinations of more elevated complexity among which the examinations of medical-genetics.

The ultrasound tests are delivered, where technically possible, in real time.
